The QBS Audit for the period of April - June 2022 substantiated the approved Budget of Revenue and Expenditures for 2022 have been updated monthly and presented to the QBS Board as required. All Income and Disbursement requests have been documented and have the requisite signatures.

The QBS Audit for the period April - June 2022 indicates there were no payments to guild members for work/time or services as stated in the By-Laws. There have been payments provided to various guild members for expenditures allowed as described in the By-Laws such as reimbursement for Community Relations supplies but no additional remuneration was provided for time or services.

The QBS Audit for the period April - June 2022 found one disbursement without corresponding documentation, however our Treasurer provided documentation to correct the issue. All other reimbursement requests were properly completed and all required documents are attached (i.e., receipts). There are no other discrepancies.

The QBS Audit for the period April - June 2022 shows one cancelled workshop where refunds were required. Two refunds were processed and one registration was applied to another workshop per member's request. Additionally, one refund was processed for the Summer Retreat for health reasons.

The QBS Audit for the period April - June 2022 shows there is no one receiving the newsletter by mail.

During the QBS Audit for April - June 2022, the bank statements were reconciled against the records in the Treasurer's binder. There are two QBS Bank Accounts. The first is a Money Market Savings Account. Below are the balances in each month. There are no concerns relative to this account.

#### **Another travel Adventure with Barbee Tidball**





A road trip up the Pacific Coast is a beautiful journey and this time we augmented our travels with a stop at an old favorite, the Latimer Quilt and Textile Center in Tillamook, Oregon and a new favorite the Pacific Northwest Quilt & Fiber Arts Museum in La Conner, Washington. Latimer (latimerquiltandtextile.com) has on site work rooms for quilters and weavers as well as an exhibit space. I met a weaver who travels to Tillamook for the opportunity to weave with other enthusiasts/artists a

couple weeks in the summer. In the sewing room I rummaged thru a few boxes of donated fabric and chatted with quilters working on hand projects.

The highlight at Latimer was their summer exhibit including a variety of very textured art and colorful quilts. There were





fabric bowls using quilting techniques that were very intriguing, and the thread painting on quilts like the dancers above, gave the quilt a very graceful kinetic dimension.

I made two visits to LaConner, Washington and each time visited the Pacific Northwest museum (www.qfamuseum.org). LaConner is an old river fishing town with lots of shops and good places to relax over oysters and a glass of wine or fish & chips with a beer. Three exhibits were on display, The Essence of Japan with works by Japanese quilters; another exhibit featured art quilts from the Contemporary Quilt Art Association and there was a fiber art exhibit intertwined with quilt displays.
